Terms and Conditions

Deposits, Final Payment, And Cancellations

A deposit of \$800.00 per person is due by May 9, 2016 to secure a confirmed reservation on the tour.

Final payment falls due on June 10, 2016

There is a cancellation fee of 600.00 per person imposed for any canceled deposit made before June 10, 2016 to cover prepaid tour tickets such as opera tickets, hotel accommodations and other arrangements. For cancellation made between June 11, 2016 and July 13, 2016, the penalty for canceling is 45% of the tour rate per person. From July 13, 2016 to July 31, 2016 the penalty is 70% of the tour rate per person. After August 1, 2016, no refund can be given. All cancellations must be received in writing. No refunds for unused services offered. A minimum of 12 tour participants is required to operate the tour.

Optional Tours

Optional tours to Bandelier National Park, Taos, or Georgia O'Keeffe's home in Abiquiu will operate with a minimum of four (4) tour participants. Rates to be advised.

Insurance

Trip cancellation insurance is strongly recommended. We are offering group travel insurance, which covers one for canceling because of a pre-existing medical conditions for the insured or member of your family, accident and sickness medical expenses, and trip delays over 12 hours, and baggage loss. The rate is \$195.00.

Our group flight will be on United Airlines departing from San Francisco to Albuquerque and returning to San Francisco.
